**AUTHORIZE SECRETARY MANAGER FREEMAN TO AWARD  
 CONTRACT 2010-01 KID MAIN CANAL SEALING AND  
 APPROVE \$30K ADDITIONAL EXPENSE DUE TO USBR WATER  
 CONSERVATION FIELD SERVICES PROGRAM (WCFSP) GRANT AWARD**

**WHEREAS**, the Board must authorize the award of the contract because it is in excess of \$100,000.00 (One Hundred Thousand Dollars); and

**WHEREAS**, this project is a budgeted Capital Project originally budgeted not to exceed \$150,000.00 (One Hundred Fifty Thousand Dollars); and

**WHEREAS**, the KID has been notified of a matching fund award in the amount of \$30,000.00 (Thirty Thousand Dollars) through a WCFSP Grant Application (**Resolution 2009-30**) for this project and requests approval to increase the project spending by \$30,000.00 (Thirty Thousand Dollars) for a revised total project expense not to exceed \$180,000.00 (One Hundred Eighty Thousand Dollars); and

**WHEREAS**, Contract 2010-01, KID Main Canal Sealing Spring 2010 was solicited for bid to four specialized bidders and bid proposals were received and opened on February 18, 2010; and

**WHEREAS**, the lowest responsible bidder for Contract 2010-01 KID Main Canal Sealing Spring 2010 is Hydro Consulting, LLC of Pasco, Washington and the bid submitted is as follows; and

**WHEREAS**, the total of the Base Bid, Alternate 1 and Alternate 2 is \$177,761.45 (One Hundred Seventy Seven Thousand Seven Hundred Sixty One Dollars and forty five cents) and is within the project budget. (Alternate 3 will not be awarded at this time).

**NOW, THEREFORE, BE IT RESOLVED** that the Kennewick Irrigation District's Board of Directors approves a \$30,000.00 (Thirty Thousand Dollars) increase to the project expense due to the matching fund WCFSP grant award with a revised project total not to exceed \$180,000.00 (One Hundred Eighty Thousand Dollars) and authorizes Secretary Manager Freeman to award **Contract 2010-01 KID Main Canal Sealing Spring 2010** to Hydro Consulting, LLC in the amount of \$177,761.45 (One Hundred Seventy Seven Thousand Seven Hundred Sixty One Dollars and forty five cents) as outlined above.
