RESOLUTION 2010-26**

**WAIVING COMPETITIVE BIDDING; AUTHORIZING THE USE OF A SOLE SOURCE CONTRACTOR, SEPRO CORPORATION, TO SUPPLY HERBICIDES AND SUPPORT FOR THE DISTRICT'S AQUATIC WEED CONTROL PROGRAM; AND AUTHORIZING THE DISTRICT PURCHASE THE HERBICIDES FROM SEPRO CORPORATION.**

**WHEREAS**, the District has a need to purchase aquatic herbicides to control aquatic vegetation within the district's boundaries; and

**WHEREAS**, the Engineering and Operation Departments determined by a thorough vendor search that SePRO Corporation is the only vendor with the appropriate aquatic weed control program that meets the District's aquatic vegetation control needs; and


**WHEREAS**, SePRO Corporation, has submitted a proposal to provide a guaranteed aquatic weed control program and will warrant any undesirable vegetation within the treated areas; and


**WHEREAS**, District staff has thoroughly analyzed the proposal submitted by SePRO Corporation and has determined the offered price for the 2010-2011 Aquatic Weed Control Program to be fair and reasonable, and recommended it would be in the District's best interest to accept the proposal; and

**WHEREAS**, the Engineering and Operations Committee has considered the report of District staff, past working experience with SePRO Corporation for the District's aquatic weed control needs has concluded that the proposal submitted by SePRO Corporation, is fair and reasonable, and determined it would be in the District's best interest to accept the proposal.

**NOW, THEREFORE, BE IT RESOLVED** that the Kennewick Irrigation District Board of Directors waives competitive bidding, authorizes the use of a sole source contractor, and authorizes the District Manager to execute a contract with the SePRO Corporation, for the 2010-2011 Aquatic Weed Control.

Resolution 2010-26 is hereby adopted by the Board of Directors of Kennewick Irrigation District, Benton County, Washington, at an open public meeting thereof this 19<sup>th</sup> day of October, 2010.
