**SET PUBLIC HEARING DATE FOR PROPOSED ROYAL ANN ESTATES  
IRRIGATION SYSTEM LOCAL IMPROVEMENT DISTRICT**

A RESOLUTION of the Board of Directors of Kennewick Irrigation District, Benton County, Washington, for the purpose of setting a public hearing for the formation of the **ROYAL ANN ESTATES IRRIGATION SYSTEM** Local Improvement District (LID), consisting of the **Plat of Royal Ann Estates Phase 1**, as recorded in volume 15 page 220, records of Benton County, lying in Section 14, Township 8 North, Range 29 East W.M. and of the **Plat of Royal Ann Estates Phase 2**, as recorded in volume 15 page 221, records of Benton County, lying in section 14 Township 8 North, Range 29 East W.M., shown generally on attached map, Exhibit A, in accordance to RCW 87.03.480.

**WHEREAS**, the District has completed the feasibility study, and found that the proposed LID is feasible, and,


**WHEREAS**, the Board is required to fix a time and place for the hearing and to cause notice of that hearing to be published and mailed;




