WHEREAS, KID General Purchasing Procedure 2.13, Paragraph 6.3.1.2 provides for a sole source purchase if the item is a licensed or patented product with only one dealer; and

WHEREAS, Rubicon control gates, Amiad automatic flushing filters, and the Red Mountain system and Cherry Creek Regional Reservoir and Pump Station are utilizing Allen-Bradley PLCs; and

WHEREAS, 4 Channel Analog Input Cards are needed to monitor the trash rack sites that are being added to the remote system; and

WHEREAS, Factory Talk Studio Machine Edition software is needed to program and backup the touch screen controls currently in the Cherry Creek facility, the Kiona Pump Station, the 810 reservoir on Red Mountain, and additionally a touch screen to be installed in the Cottonwood Meadows Pond and Pump Station; and
